



<b>Enrollment/ Registration Steps</b>	<ol style="list-style-type: none"> <li>1. Get a copy of the Enrollment/Registration Forms (CAT Exam Application Form and Topnotch Registration Checklist). Enrollment/registration forms are available at Topnotch Office or NRC; or download the enrollment/registration forms via our website <a href="http://www.topnotchcatreviewers.com">www.topnotchcatreviewers.com</a>.</li> <li>2. Fill out the CAT Exam Application Form and submit the form together with the required attachment to registration personnel or representatives of Topnotch CAT Reviewers at Topnotch Office or NRC. Submit your payment to registration personnel or representatives of Topnotch CAT Reviewers at Topnotch Office or NRC.</li> <li>3. After submission of CAT Exam Application Form and after payment, accomplish the online registration and submission of other requirements via e-mail. Refer to Topnotch Registration Checklist for complete instructions and requirements.</li> </ol> <p><i>Off-site enrollment/registration: (for those who cannot come to the office for enrollment/registration)</i></p> <ul style="list-style-type: none"> <li>• Coordinate with Head of Topnotch for the approval of off-site registration. (text this number and include your name: 0917-8827111)</li> <li>• Accomplish the online registration and send via e-mail the applicable requirements.</li> <li>• Payment of fees via bank deposit. (coordinate with Head of Topnotch for the bank account details)</li> <li>• On the first day of review, submit the CAT Exam Application Form and required photocopy attachment and signed-off Topnotch Registration Checklist. (Or send the complete requirements via courier 3 days before first day of review or as agreed upon with Head of Topnotch.)</li> </ul>
